

Your child may be entitled to...

- ✓ **Free Early Learning and Childcare** for Two Year Olds (Funded 2s)
- ✓ **Early Years Pupil Premium** for Three and Four Year Olds (EYPP)
- ✓ **Free School Meals** for school-age children (FSM)



...if you are on a low income and in receipt of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The Guarantee element of State Pension Credit
- Child Tax Credit (CTC) with an annual gross income of no more than £16,190 (for FSM / EYPP only)
- Child Tax Credit (CTC) and Working Tax Credit (WTC), with an annual gross income of no more than £16,190 (for Funded 2s only)
- Universal Credit with annual take home pay of no more than £7,400 (FSM / EYPP only) and annual take home pay of no more than £15,400 (for Funded 2s only).

Free Early Learning and Childcare (for Two Year Olds)

Free 15 hours (over 38 weeks) Early Learning and Childcare for eligible 2 year olds.

This is a maximum of 570 hours over 12 month period, from the term after they turn 2.

Free School Meals (FSM)

Available to school-age children and to Post-16 students at a school with a sixth form or college. Saving you up to £400 per year for each child.

All children receiving free school meals will continue to receive them until the end of their current phase of schooling.

Early Years Pupil Premium (Three and Four Year Olds)

Additional funding paid directly to your child's early years provider to support their learning and development.

Once your child moves into school, they may then be entitled to free school meals.

Pupil Premium (school-age children)

If your child has been identified as being eligible for FSM, additional funding is paid directly to the school to be used to support their learning.

Home to School transport (11 – 16 year olds and 16 – 19 year olds)

If your child is aged 11-19 you may wish to find out about transport entitlement at www.cambridgeshire.gov.uk/education/transport or telephone 0345 045 5208.

16 – 19 Bursary Scheme (16 – 19 year olds)

Funding to help with education-related costs for young people aged 16 to 19 who are studying at school or college (not university) in England, or who are on a training course, including unpaid work experience.

Each school and college will have their own scheme and qualifying criteria, but most, if not all, include these benefits as a starting point for eligibility.
