Whole Housing Approach

MISSION To improve housing options for families affected by domestic abuse through a 'whole housing approach' rather than just one size fits all approach.

VISION To develop and model Whole Housing approaches and to evaluate their impact in terms of:

- Reducing homelessness
- Early intervention
- Increasing tenancy sustainment
- Providing move on options for families affected by domestic abuse.




Background and development of Whole Housing

- May 2018 DAHA develop outline of the Whole Housing Approach and presents it to the DA National Housing and DA Policy and Practice group as part of DA Bill consultation. The group endorses Whole Housing and response is sent which is then used as written evidence by Home Affairs Select Committee
- Nov 2018 Whole Housing included as response to Social Housing Green Paper
- Nov 2018 MHCLG funding secured to pilot Whole Housing in 3 areas Cambridgeshire and Peterborough, Stockton and West London Tri-Borough
- Jan 2019 Whole Housing approach recognised in DA Bill

Mobile Advocacy (Outreach)

Trauma informed person centred advocacy working with victims where they are and supporting them with their needs and the outcomes they are seeking.

7 members of staff across Cambridgeshire and Peterborough

Easy to Access

Any level of risk

Trauma Informed Practice

Flexible



Managed Reciprocals

Aim is to enable victims/survivors and their children to move to a safe area

- Reasonably quickly
- Same Size Property
- Maintaining their Social Tenancy

First scheme outside of London

First scheme in the world to include perpetrators

South Cambs, Cambridge City, Fenland, East Cambs and Clarion have already signed up to the Memorandum of Understanding.

Peterborough and Hunts are close to signing.

Flexible Funding (Resident Support Scheme)


'Flexible funding assistance refers to unrestricted funds used to support survivors to become stably housed'

Aim is to prevent homelessness to survivors by providing assistance that is:

- Immediate
- Individualized
- flexible

Principles are:

- Low barrier
- Fast
- No cap on amount



Examples:

- Issued to people with No Recourse Public Funds
- Removal van





Perpetrator Management

- > Enforcement (starting with a victim led approach)
- Positive engagement (Respect accredited)
- Cambs Domestic Abuse Perpetrator Panel
- Domestic Violence Protection Order ensuring housing are informed
