#### 1. Introduction & Purpose of Report

The Ministry of Housing, Communities & Local Government (MHCLG) has released the English Indices of Deprivation 2019<sup>1</sup>, which are combined into the composite Index of Multiple Deprivation (IMD) 2019. These data are the first update to the IMD since 2015 and are the official measure of relative deprivation in England. This report summarises data calculated by Cambridgeshire & Peterborough Public Health Intelligence which provide IMD data at Provider Alliance (Alliance), Primary Care Network (PCN) and General Practice (GP) level for Cambridgeshire & Peterborough Clinical Commissioning Group (C&P CCG), which is comprised of two Alliances, 21 PCNs and 88 GPs as of November 2019. PCN groupings took effect in 2019 but data are provided based on these groupings for 2015 and 2019 for comparative purposes.

IMD data are provided by MHCLG at Lower Super Output Area (LSOA) level – geographical areas of approximately 1,500 residents, each which do not change, and therefore allow for direct comparison between time periods. Through analysis of GP populations at LSOA level, as provided by NHS Digital<sup>2</sup>, GP-level IMD data may be calculated via a weighting method. This uses the IMD values of each LSOA and the proportion of the total GP register living within each LSOA to calculate a weighted average for the practice. These data may in turn be used to calculate PCN and Alliance IMD values. Cambridgeshire & Peterborough Public Health Intelligence have used this method to calculate relative deprivation for all Alliances, PCNs and GPs within C&P CCG and this report contains data for each of the 10 domains/subdomains within the IMD illustrating:

- 1. Relative deprivation rankings by quintile (fifths) for each of C&P CCG's 21 PCNs
- 2. PCN-level comparison of 2015 and 2019 IMD scores and relative CCG rankings
- 3. Relative deprivation rankings by quintile for each of C&P CCG's 88 GPs

4. Illustration of the 10 most relatively deprived and 10 least relatively deprived GPs within C&P CCG, including comparison to 2015 data, for each IMD domain/subdomain

Within IMD data, there is one overarching IMD value, seven subdomains and two supplementary indices (IDACI and IDAOPI) that contribute to the income sub-domain to give a total of 10 domains/subdomains within this analysis:

- 1. Index of Multiple Deprivation (IMD) the overall summary value of relative deprivation for an area
- 2. Income the proportion of the population experiencing deprivation relating to low income
- Income Deprivation Affecting Children Index (IDACI) the proportion of all children aged 0 to 15 living in income deprived families, which contributes towards the income subdomain
- Income deprivation Affecting Older People Index (IDAOPI) the proportion of those aged 60+ who experience income deprivation, which contributes towards the income subdomain
- 5. Employment the proportion of the working age population in an area involuntarily excluded from the labour market
- 6. Education the level of educational attainment and skills in the local population
- 7. Health the risk of premature death and the impairment of quality of life through poor physical or mental health
- 8. Crime measures the risk of personal and material victimisation at local level
- 9. Housing measures the physical and financial accessibility of housing and local services
- 10. Living environment measures the quality of both the 'indoor' and 'outdoor' local environment

It is important to note that IMD data measure relative, rather than absolute, deprivation. Resultantly, the data may only be used to ascertain whether a GP, PCN or Alliance has become more or less relatively deprived in relation to other similar units of comparison (e.g. whether a PCN has become more or less deprived relative to other PCNs within C&P CCG) rather than as a measure of absolute change over time. Relative rank positon is used to make the comparisons rather than the actual IMD scores. Rank 1 is the most deprived.

#### 2. Key Findings

- The 2019 IMD is the first update to IMD data since 2015. Cambridgeshire & Peterborough CCG has become relatively more deprived in comparison to other CCGs in England between 2015 and 2019, with a fall in IMD ranking from 152<sup>nd</sup> to 139<sup>th</sup> position in England.
- Data show little change in relative deprivation over this period, with Cambs Northern Villages PCN remaining the least relatively deprived PCN within C&P CCG and Central and Thistlemoor PCN, Octagon Wisbech PCN and BMC Paston PCN remaining the most relatively deprived PCNs within the CCG.
- Central Thistlemoor PCN is ranked as the most deprived PCN within C&P CCG for six of 10 domains/subdomains within this analysis; IMD, IDACI, IDAOPI, income, education and crime.
- PCNs primarily based in and around Peterborough continue to be relatively more deprived than PCNs in other parts of C&P CCG, although notably high levels of relative deprivation are observed for some domains/sub-domains in Fenland and Cambridge.
- Income deprivation affecting children continues to be most prevalent in Central and Thistlemoor PCN and Octagon Wisbech PCN and least prevalent in Granta PCN and Meridian PCN in 2019; these rankings are unchanged since 2015.
- Central and Thistlemoor PCN, BMC Paston PCN and Octagon North PCN remain the most relatively deprived PCNs with regard to income deprivation affecting older people in 2019, which is unchanged from 2015. Meridian PCN remains the least relatively deprived PCN for this sub-domain.
- Among individual general practices (GPs), Dogsthorpe Medical Centre, Westwood Clinic and Central Medical Centre are the three most relatively deprived practices within C&P CCG; all three of these practices are within Peterborough. The three least relatively deprived practices within the CCG are Over, Swavesey and Firs House, Histon.
- Although ranked as the most relatively deprived practice in C&P CCG, Dogsthorpe Medical Centre is ranked within the most deprived CCG quintile for eight of 10 domains/subdomains within this analysis – Westwood Clinic, Central Medical Centre and Welland Medical Practice are ranked within the most deprived CCG quintile for nine of 10 domains each.
- Over and Swavesey are the only two GPs within C&P CCG to be ranked in the least deprived CCG quintile for all 10 domains/subdomains within this analysis.

#### 3. Cambridgeshire & Peterborough Clinical Commissioning Group Overview

Data show that between 2015 and 2019, Cambridgeshire & Peterborough CCG has become relatively more deprived compared to other CCGs within England. C&P CCG was ranked  $152^{nd}$  most deprived in England in 2015, of a total of 209 CCGs. In 2019, C&P CCG has fallen to now be the  $139^{th}$  most deprived in England, a change in rank of -13.

C&P CCG has fallen in rank between 2015 and 2019 for all domains and subdomains within the IMD, as reflected in Figure 1, above. The greatest observed change for C&P CCG is within the Crime subdomain (-31) and the smallest observed change is in the education subdomain (-1). This suggests that C&P CCG has become relatively more deprived than other CCGs over the 2015 – 2019 time period, although observed changes in ranking are relatively small within the context of the 209 CCGs within England.

#### 4. Primary Care Network IMD Data

The 21 PCNs within C&P CCG are ranked within the above table by relative IMD score, from '1' - most relatively deprived to 21 - least relatively deprived. Shading reflects relative CCG quintile of deprivation rather than the result of a statistical test of significance. Relative deprivation may be helpful in targeting interventions and setting and assessing priorities. Central and Thistlemoor PCN is the most relatively deprived PCN within C&P CCG, with

Octagon Wisbech PCN, BMC Paston PCN, Octagon North PCN and Peterborough Partnerships PCN also being within the most relatively deprived quintile within the CCG for a number of domains.

Conversely, Cambs Northern Villages PCN is the least relatively deprived PCN within the CCG and tends to fall within the least deprived quintile of the CCG for most domains, as do Granta PCN and Meridian PCN.

The most deprived PCNs within C&P CCG remain Central and Thistlemoor PCN, Octagon Wisbech PCN and BMC Paston PCN. Cambs Northern Villages PCN remains the least deprived PCN. Little relative change is observed for any of the PCNs within the CCG and relative deprivation remains markedly higher in North Alliance compared to South Alliance.

Central and Thistlemoor PCN and Octagon Wisbech PCN remain the most deprived PCNs within the CCG with regard to income deprivation affecting children. Granta PCN and Meridian PCN remain the least deprived PCNs within the CCG for this domain. Between 2015 and 2019, only two PCNs have changed in rank by more than one position; Ely North PCN has improved by three positions and Cantab PCN has worsened from 16<sup>th</sup> to 14<sup>th</sup> position within the CCG. The measured percentage of children living in income-deprived households has reduced between 2015 and 2019 in North Alliance, South Alliance and the CCG.

When ranking PCNs by income deprivation affecting older people, all PCNs remain within one position of their 2015 relative ranking in 2019. Central and Thistlemoor PCN and BMC Paston PCN therefore remain the most deprived PCNs within the CCG as per this indicator and Meridian PCN remains the least deprived.

The income sub-domain measures the proportion of the population experiencing deprivation relating to low income and accounts for 22.5% of the overall IMD score. Central and Thistlemoor PCN and BMC Paston PCN remain the most relatively deprived PCNs within the CCG for this indicator, whereas CAM Medical PCN, Meridian PCN and Granta PCN remain the least deprived PCNs.

The employment sub-domain measures the proportion of the working-age population in an area involuntarily excluded from the labour market and contributes towards 22.5% of overall IMD scores. Octagon Wisbech is the most deprived PCN within C&P CCG for this sub-domain in 2019, with CAM Medical PCN and Granta PCN remaining the least deprived PCNs.

The education sub-domain measures the lack of educational attainment and skills in the local population with reference to both pupils of school age and adults. Central and Thistlemoor PCN, Octagon Wisbech PCN and BMC Paston PCN remain the most relatively deprived PCNs within the CCG for this sub-domain, whereas CAM Medical PCN, Cambs Northern Villages PCN and Cantab PCN remain the least relatively deprived PCNs.

The health sub-domain measures the risk of premature death and the impairment of quality of life through poor physical or mental health of individuals and contributes 13.5% towards overall IMD scores. Octagon Wisbech PCN is the most relatively deprived PCN for this sub-domain. Granta PCN has improved from 19<sup>th</sup> to 21<sup>st</sup> (best) within this subdomain and Cambs Northern Villages PCN has improved from 18<sup>th</sup> to 20<sup>th</sup>. Meridian PCN has fallen from 21<sup>st</sup> to 18<sup>th</sup> within the relative rankings.

The crime sub-domain accounts for 9.3% of IMD scores and measures the risk of personal and material victimisation at a local level. Central and Thistlemoor PCN remains the most relatively deprived PCN for this sub-domain and Granta PCN remains the least relatively deprived. It is notable that a higher degree of movement with regards to PCN rankings is observed for this sub-domain compared with many other sub-domains, with Ely North PCN and St Ives PCN improving their respective rankings by four positions and Meridian PCN and Cambridge City 4 PCN moving down within the rankings by three positions each.

The Housing sub-domain measures the physical and financial accessibility of housing and local services and accounts for 9.3% of overall IMD scores. Ely North PCN remains the most relatively deprived PCN within C&P CCG for this sub-domain and Ely South has fallen by one position to be the second most deprived PCN within the CCG. St Neots PCN has improved by a highly notable 11 positions within the rankings and is now the least deprived PCN within the CCG.

The living environment sub-domain contributes 9.3% towards overall IMD scores and measures the quality of both the indoor and outdoor local environment. CAM Medical PCN is the most relatively deprived PCN within the CCG for this sub-domain, as was also the case in 2015. Cambs Northern Villages PCN is the least deprived PCN. It is notable that Fenland PCN has improved by 7 positions, from 13<sup>th</sup> to 20<sup>th</sup> rank, in 2019 and is now the second least deprived PCN for this indicator.
